1. Manual Scavenger Reach

AID organization involved in Davanagere and Harihara are continuously visiting the Scheduled Castes colony of Jagurur city. Identify this by identifying those who have been working on manually by clearing the pits that are not connected to sewers in the city, according to the Manual Scavenger Prohibition and Rehabilitation Act-2013, which the central government has implemented. We are applying mainly from 125 families. We are entitled to a proper rehabilitation under this Act.

After these initiatives in Davangere district have begun, the Urban Development Department has created the whole state as a model and re-assignment. However, the government is delaying the appropriate decision. Manual scavengers continue to struggle in this regard.

According to the 2011 census, we have re-evaluated 100 Rural Manual Scavenger in Rural Area. But they are incorrectly added. We have conveyed this to the government.

The city of Davangere has come under the supervision of the SafaiKarmachari Watch Committee. AID used songs and street plays about identifying manual scavengers. AID reach out to 156 Manual Scavengers.

2. Identification of Bondedlabourer

We have targeted 76 bonded labourers in Davanagere district. But so far they have not got the facilities according to the law. We've made continuous efforts to get this done. Officials have found the need to focus on them. Officials have gone to rehabilitate and given false accusations that there are not slaves in the villages. Overall, they are neglected. That is, persistent communities have been persecuted by subsequent exploitation by caste system.

3. Awareness of Scheduled Caste Sub-Appropriation Act.

The Scheduled Castes and Scheduled Tribes Sub-Plan will be trained in various wards of Davanagere. It is important to note that government

plans will not reach eligible families. In this regard, it is decided to create a list of eligible families to receive social benefits. Qualified families have been asked to involve in government plans. Projects need to go to illiterate families at their doorstep. In this regard governments have decided to make a strategy to advocate planning.

4. Child Rights Awareness Campaigns.

In Jagalur, we have imparted awareness on Child Rights to the children and head of the various schools. We are training about the protection of children from sexual offence Act 2012.

Juvenal justices Act (care and Protection) Under this Act, we have provided residential facilities for 12 destitute children. And we have sponsorship a plan for 2 children.
